CONDITIONS OF ENTRY, FEES & CONTRIBUTIONS

Entry fees will be deducted from the sale proceeds or invoiced at the time of sale. The entry fee includes all stabling charges and inspection fees at the sale.

I/We (the Vendor hereinafter named) hereby nominate the horse/s appearing on this form for inclusion in the 2018 Inglis Yearling Sale Series to be conducted by William Inglis & Son Ltd (the Auctioneer) in accordance with the Conditions Of Sale (which can be viewed at www.inglis.com.au/cos) and other provisions appearing on this form.

The Vendor warrants the truth and accuracy of the details and other information furnished on this form and hereby agrees to indemnify the Auctioneer in respect of any loss or damage it may suffer by reason of any false, erroneous or inaccurate matter being inserted on this form.

The Auctioneer may in its absolute discretion accept or reject any entry and its decision shall be final and binding on all parties.

The following charges will be payable by the Vendor and will be deducted from the proceeds of each Lot sold or invoiced at the time of sale.

- (a) The entry fee as determined once the horse/s have been accepted to a Sale as per the below table.
- (b) Commission at a rate of 8.5% plus GST of the sale price up to \$250,000 and 6.5% plus GST thereafter on the remaining balance on each lot catalogued, whether sold by auction, private contract, bought in or otherwise.
- (c) This is a reserved sale. Any lot offered and not sold shall be subject to pass in commission at a rate of 2.5% plus GST of the reserved price.
- (d) A promotional fee of 1% plus GST will be deducted from all yearlings sold. Of this amount 0.35% will be passed on to assist with funding of Thoroughbred Breeders Australia and 0.65% will be used to fund an Inward Buyers program to each sale.
- (e) A contribution as determined in the below table will be deducted from the proceeds of the sale of each lot sold and put towards prize money for the Inglis Race Series.
- (f) Any Lot nominated for the Sale cannot be withdrawn by the Vendor, after the assigning of the horse's lot number for the Sale Catalogue, without the forfeiture of the Entry Fee, except in the event of injury, death or illness of the Lot. Apart from death of a Lot (in which case the Entry Fee shall not be charged), in all cases of alleged injury or illness if the Vendor at his expense produces a Veterinary Certificate, within thirty (30) days from the completion of the Sale, confirming the existence of the injury or illness alleged, 50% of the Entry Fee shall be charged. Should the Vendor not produce an acceptable Veterinary Certificate, the Vendor will, on demand being made by Inglis, be liable to pay the Auctioneer 5% (plus GST) of the median sale price for the Selling Session in which the withdrawn Lot was listed, as liquidated damages, in addition to the Entry Fee.
